**Description:** : The Minneapolis North High School track and field stadium was constrained by city streets and a private parking lot. The site contained original school foundations, basement tunnels, and coal burning furnaces which needed to be removed and treated to meet environmental and structural requirements of a new running track and synthetic turf field. Bolton & Menk provided site planning, civil engineering, and landscape architectural services through the facility redesign and revitalization process while working with school staff and involving community members. Through in-depth neighborhood and school involvement during the planning process, the new stadium has been embraced by the community and will be a landmark for years to come.

# ACEC Research Institute Study: Provision of Engineering Services on a Lump Sum Basis



The ACEC Research Institute commissioned this study – in partnership with Virginia Tech – to enhance awareness of the potential opportunities and challenges of lump sum structures for engineering and design services in the transportation sector. The study undertook expert interviews to provide a rich data set on perspectives surrounding lump sum contracting. Researchers conducted interviews with 14 client organizations made up of nine DOTs, three federal agencies, and two public transportation authorities.


